Council objects to this application due to its obtrusive position on the street frontage of the property. It is concerned about the scale in particular the apex height and the impact on the exclusive parking and access to the holiday cottage – condition of NP/DDD/1105/1053. This facility would be better positioned away from the roadside to avoid these concerns.
