654 Planning decisions/applications received since last meeting & planning related matters

Decisions received: NP/DDD/0920/0840 - Buxton House Proposed replacement extension to dwelling -NP/DDD/0820/0802 - FIELD PARCEL NUMBER SK1070 4742 CHELMORTON Erection of 2 stables with adjoining feed store on a concrete base

Applications returned to meet deadline:- none Applications for discussion: NP/DDD/1020/0941 - Town End Farm - proposed new build to satisfy a local need No further comment to committee - 15<sup>th</sup> January

NP/DDD/1120/1113 Far Ditch Farm Section 73 application for the removal or variation of conditions 7 and 10 on NP/DDD/1215/1183

Council has no objection to allowing the caravan site to increase its opening to year round as this is a well kept and maintained hardstanding area and therefore supports the removal of clause 7 for this purpose.

Council has to reflect the views of parishioners who have major complaints about the increases in opening periods for camping fields, rowdy groups, heavy littering and the crowding and saturation of the local amenities that has majorly increased over the last couple of years. It considers that any expansion of the number of fields available for camping will overburden the community and consideration needs to be given to enforcement of capacities with adequate spacing on existing permissions to prevent crowding of sites before the next season starts.

Council therefore objects to the removal of clause 10 and does not wish to see more camping fields being allowed in this parish.

NP/HPK/1220/1138 - Section 73 Planning Application Code No: NP/HPK/1220/11 for the variation of conditions of planning permission NP/HPK/0814/0882 and details part-discharged under planning permission NP/DIS/1217/1251 for a revised working and restoration scheme at Topley Pike Quarry and Deep Dale and increased dispatch of stone

Council supports this scheme but would like to see a community benefit in the increased traffic created for more maintenance to highways in the area – replacement of signs and

new signs on the 7.5 Tonne zones. Too many HGVs follow satnavs onto Common Lane and get stuck at the T junction in the village or cut into the zone along the Ditch and turn right up Pippenwell Lane which is a single track with passing places and severe drops on either side that several HGVs have need recovery from and urgently needs a warning sign as well as prosecution of drivers for being inside the zone. Council would therefore like to see money specifically allocated to this area to improve conditions for our parishioners due to the wear and tear and damage caused by HGV traffic.

NP/DDD/0121/0013 The Green (Chapman) Main Street Council supports this application which will tidy up and improve the look of the property

# 655 Footpaths and Highways and related issues

Clerk reports: - Single track sign for Pippenwell to be chased F763607 latest code. It is noted that Pippenwell is inside the 7.5T zone and if photos are taken and the photographer willing to sign a statement they should be sent to Trading Standards <u>Derbyshire County Council</u> form: Weight restriction monitoring with time and date who will investigate and prosecute. DCC long term solution for blocked gullies – the meeting was pleased to learn that a contractor has been found for the field sump clearance and DCC hopes to carry this out in the next couple of weeks. Thanks were expressed to our resident Highways Engineer for his diligence and perseverance and liaison with the local DCC Engineer to organise this.
