723 Public Speaking

Apologies were received from County Councillor Simon Spencer and PCSO Benjamin Morris. Keith Woolley updated council on the site meeting between DCC Highways and Severn Trent this afternoon. All sewer and surface water pipes have now been photographed. A plan has been agreed for STW contractor Amey to repair 7 sections of the sewer where water pipes have crossed through the glazed pipe and thereafter DCC will produce a scheme to upgrade the remainder – due to the number of services in the road it is more likely the sewer will be repaired than a new one laid.

Decisions received: NP/DDD/0821/0923 - Lyndene - 2 storey rear extension - granted

Applications returned to meet deadline: NP/DDD/0921/1002 Far Ditch Farm S.73 variation of condition 6 on NP/DDD/0317/0223 to use existing caravan touring site all year round

Council supports this application for year round use for caravans but would note that the incremental creep in amendments to the site needs to reach a conclusion as whilst this is deemed a well run caravan site, Council would not like to see further expansion into other areas.

It notes that winter access can be affected by gritting routes and that onsite management is a necessity that seems to be lacking from parishioner comments received so would wish to see no camp site permission without full time onsite presence.

NP/DDD/0921/1010 - Land South of Church Lane - Redevelopment and enhancement of yard with one open market dwelling and workshop

Council objects to this application as its style is totally out of character for the village and that part of the village in particular. The scale of the proposed dwelling is out of character and the sheer size of each bedroom and associated bathroom/toilets/shower rooms does not suggest it will be used as family accommodation.

There is an urgent need to provide affordable properties for local youngsters who cannot afford to buy in the village. Those recent new build properties which have been of an affordable size and price have been turned into holiday lets etc by the owners and council wishes to see local needs provided for as the only new builds / conversions allowed until those needs are met.

Clerk to contact Vertas as the verge opposite Ditch House ie between Netherlow Farm and No1 The Ditch has not been mown again.

Litterpicking – a group is being organised and further litter pickers and pink bags are requested.
