Applications for discussion: NP/DDD/0323/0344–Land and buildings to south-west of Church Lane, Chelmorton = Proposed replacement of large agricultural building with new residential dwelling.

Council objects to this application as it's style is totally out of character for the village and that part of the village in particular. The scale of the proposed dwelling is out of character and its height is not in keeping with the conservation area. There is an urgent need to provide affordable properties for local youngsters who cannot afford to buy in the village. This site was one of those looked at during the last round of sorely needed affordable housing plots in the village and Council would prefer to see a development to keep younger generations in the village prioritised by planners.

NP/DDD/0423/0413 Shepley Farm, Unnamed Section Of Road Between Main Street And Old Coalpit Lane, Chelmorton - Proposed agricultural slurry store

Council supports this application enabling a working farm to improve its environment.

856 Footpaths and Highways and related issues

Signage and verges at Pippenwell – DCC to be contacted again for a "road blocked after first house" winter sign and to look at steep verges. Cllrs to ask for the caravan at the junction with Common Lane to be moved as it affects sight lines and turning. The request to DCC to move the 30 mph sign to the edge of the village will be made. A request for an additional dog bin at the top of the village will be passed on to DDDC. Mowing grass verges on the Ditch – DDDC map details to be passed to councillors.
